<u>Experience</u>- A minimum of three years' full-time work experience in electrical engineering and/or electrical and computer engineering technology is required. Work experience should include those competencies, skills, and knowledge levels which the instructor will be expected to teach.

### PREFERRED QUALIFICATIONS

Master's degree in Electrical Engineering, Electrical Engineering Technology, or Electrical and Computer Engineering Technology; teaching experience at the postsecondary level; active participation in appropriate professional/occupational organization; excellent human relations skills; and excellent written and verbal communications skills.
