A review of completed application packets may begin upon receipt. Interviews of qualified candidates may be held following review; the position may close at any time after August 30, 2024 based on candidate selections.

Position Summary:

Under general supervision, responsible for providing clerical assistant to the instructional staff. Completes all assignments in a timely manner and maintains accurate records. Maintain qualifications for employment as described by the Technical College System of Georgia (TCSG) Policy Manual and accreditation standards. Follows rules and regulations as described by the TCSG Policy Manual and other policies and procedures established by the institution. Position may involve traditional day and/or evening/weekend hours may require travel to any of the locations with the College's service area.

Location / Work Schedule:

This position is projected to work the following hours during the Adult Education semester session, max eligible hours per week of 29; actual hours may vary based on department needs. Position will be located in Baldwin County. May require travel to other assigned college locations and additional travel as needed.

Tuesday through Thursday: 8:00 a.m. to 3:30 p.m.

Minimum Qualifications: Must upload transcripts which show conferred educational degrees and document qualifications in the employment history:

- Proficiency in Microsoft Word, Access and Excel
- Knowledge of modern office practices and procedures

Preferred Qualifications: Preference may be given to applicants who, in addition to meeting the minimum qualifications, provide transcripts of conferred degrees and demonstrate in the employment history possession of one or more of the following:

- Documented experience teaching adults
- Documented Postsecondary college credit from an academic institution that is accredited by an institutional accrediting agency recognized by the United States Department of Education

- Documented work experience in an adult or customer service environment
- Documented proficiency in Banner information system

Salary/Benefits:

This positon is compensated at the rate of \$15.50 gross per hour. Adjunct positions are temporary, time-limited appointments encompassing a single academic term or period and do not imply or suggest a continuance of employment or a promise of future full-time employment. CGTC is a member of Teachers Retirement System of Georgia (TRS) and Employees Retirement System of Georgia (ERS). Adjunct positions are not eligible for TRS or ERS retirement benefits, state insurance, leave or holiday pay.

Application Procedure:

Applicants are required to complete the employment application in full and provide supporting documentation by the stated closing deadline for the position. GCTC does not accept mailed, faxed, or hand-delivered applications.

Applicants who complete the application procedure will be evaluated for meeting the position requirements based on the published job responsibilities, meeting the minimum and preferred qualifications based on the educational history, employment skills presented under job duties in the application system against the published job announcement. A completed application packet consists of the following:

- 1. A completed CGTC electronic application in the CGTC application portal.
- 2. As applicable, applicants for instructional positions are asked to provide a resume in addition to completing the CGTC application. Applicants for non-instructional positions may provide a resume if they wish. Submission of the resume does not replace the requirement to complete the CGTC electronic application.
- 3. Postsecondary transcripts that demonstrate the conferral of the degree, if applicable, and demonstrates the applicant meets the educational minimum requirements and, if applicable, the preferred educational requirements (*grade reports and diploma copies are not accepted in lieu of transcripts*)
- 4. Positions requiring a High School Diploma or GED as a minimum qualification do not have to submit a HSD/GED transcript documentation as part of the application process
- 5. Non-photo license(s) and/or certification(s) which fulfill the minimum, and if applicable the preferred qualifications stated in the job announcement

Incomplete application packets at the time of the position closing may not be considered. It is the responsibility of the applicant to obtain and upload the application documentation by the stated deadline.
