



Position Announcement October 2025

- Position:** Culinary Arts Instructor
- Employment Status:** Adjunct
- Application Deadline:** Open Until Filled
- Primary Work Location:** Pulaski State Prison, Hawkinsville, Ga
- Work Schedule:** up to 29 hours per week / during the academic term

A review of the completed application packets may begin upon receipt. Interviews of qualified candidates may begin following review; the position may close at any time following October 24, 2025 based on candidate(s) selection.

Position Summary:

Under general supervision, provides instruction in culinary arts skills to inmates in the correctional setting. Demonstrates the use of appropriate teaching techniques; use of appropriate testing and grading procedures including proper maintenance of grade books and any other record-keeping required; effective use of oral and written communication skills; and knowledge of current in-field procedures. Follows approved course syllabus. Maintain program requirements, attend/complete all professional development training; meet with students and college personnel to discuss students' instructional programs and other issues. Evaluates student progress in attaining goals and objectives. Completes all reports, records and invoices in a timely manner and maintains accurate inventory of all assigned properties. Maintain qualifications for employment as described by the Technical College System of Georgia (TCSG) Policy Manual and accreditation standards. Follows rules and regulations as described by the TCSG Policy Manual and other policies and procedures established by the institution. Also subject to the rules and regulations of the Georgia Department of Juvenile Justice. Position may require travel to any of the satellite locations with the College's service area as well as additional travel as needed.

Location / Work Schedule:

This position will be assigned to provided services onsite at Pulaski State Prison, Hawkinsville, Ga. Tuesday through Thursday; daily work hours to be determined. Actual work hours may vary to meet the needs of the Correctional facility. Additional hours or a flexible schedule to include evenings and/or weekends will be required as needed. This position will work all 12 months of the calendar year and up to 29 hours per week during the academic term.

Minimum Qualifications: *Must upload transcripts which show conferred educational degrees and document qualifications in the employment history*

- Earned High School Diploma or earned equivalent

- Documented one (1) year employment in the culinary field
- Documented ServSafe Certification

Preferred Qualifications: *Preference may be given to applicants who, in addition to meeting the minimum qualifications, provide transcripts of conferred degrees and demonstrate in the employment history possession of one or more of the following:*

- Earned Associates degree in field from an institutional accrediting agency recognized by the United States Department of Education
- Documented three (3) years employment in the culinary field
- Documented American Culinary Federation certification
- Documented work experience in the correctional setting
- Documented work experience in the post-secondary setting

Salary / Benefits:

Gross rate of \$20 to \$23 per hour; actual hourly rate will be determined by the candidate's degree based on minimum and preferred qualifications. Adjunct positions are temporary, time-limited appointments encompassing a single academic term or period and do not imply or suggest a continuance of employment or a promise of future full-time employment. CGTC is a member of Teachers Retirement System of Georgia (TRS) and Employees Retirement System of Georgia (ERS). Adjunct positions are not eligible for TRS or ERS retirement benefits, state insurance, leave or holiday pay.

Application Procedure:

Applicants are required to complete the employment application in full and provide supporting documentation by the stated closing deadline for the position. CGTC does not accept mailed, faxed, or hand-delivered applications.

Applicants who complete the application procedure will be evaluated for meeting the position requirements based on the published job responsibilities, meeting the minimum and preferred qualifications based on the educational history, employment skills presented under job duties in the application system against the published job announcement. A completed application packet consists of the following:

1. A completed CGTC electronic application in the CGTC application portal.
2. As applicable, applicants for instructional positions are asked to provide a resume in addition to completing the CGTC application. Applicants for non-instructional positions may provide a resume if they wish. Submission of the resume does not replace the requirement to complete the CGTC electronic application.
3. Postsecondary transcripts that demonstrate the conferral of the degree, if applicable, and demonstrates the applicant meets the educational minimum requirements and, if applicable, the preferred educational requirements (*grade reports and diploma copies are not accepted in lieu of transcripts*)
4. Positions requiring a High School Diploma or GED as a minimum qualification do not have to submit a HSD/GED transcript documentation as part of the application process

5. Non-photo license(s) and/or certification(s) which fulfill the minimum, and if applicable the preferred qualifications stated in the job announcement

Incomplete application packets at the time of the position closing may not be considered. It is the responsibility of the applicant to obtain and upload the application documentation by the stated deadline.
