**Position:** Math Instructor – High School Academy  
**Employment Status:** Adjunct  
**Application Deadline:** Open Until Filled  
**Primary Work Location:** Warner Robins campus  
**Projected Work Schedule:** Up to 29 hours per week each academic term

*A review of completed application packets may begin upon receipt. Interviews of qualified candidates may be held following review and position may close at any time following December 13, 2024 based on candidate selection.*

**Position Summary:**

Under general supervision, provides in-person instruction of High School courses to students in the classroom setting; prepares syllabi and lesson plans as needed. Develops program goals and objectives. The instructor must possess the ability to teach all phases of the curriculum. Demonstrates the use of appropriate teaching techniques; use of appropriate testing and grading procedures including proper maintenance of grade books and any other record-keeping required; effective use of oral and written communication skills; and knowledge of current in-field procedures. Follows approved course syllabus. Maintains program requirements, attends/completes all professional development training; meet with students and college personnel to discuss students' instructional programs and other issues. Evaluates student progress in attaining goals and objectives. Completes all reports, records and invoices in a timely manner and maintains accurate inventory of all assigned properties. Maintains qualifications for employment as described by the Technical College System of Georgia (TCSG) Policy Manual and accreditation standards. Follows rules and regulations as described by the TCSG Policy Manual and other policies and procedures established by the institution. Position may involve teaching traditional day and/or evening classes or online classes and may require travel within the college's service area and additional travel as needed.

**Candidate must meet one of the following (Standard Academic or Other) Qualifications:**

**Standard Academic Qualifications:**

**Minimum Qualifications:** *Must upload transcripts which show conferred educational degrees and document qualifications in the employment history:*

- Earned Bachelor's degree with a concentration (*a minimum of 18 semester hours*) in the teaching discipline from an academic institution that is accredited by an institutional accrediting agency recognized by the United States Department of Education **OR**

- Documented Passing Score in the teaching discipline on the Education Certification Exam (ex: TCT, Praxis, GACE, etc.)

**Preferred qualifications:** *Preference may be given to applicants who, in addition to meeting the minimum qualifications, provide transcripts of conferred degrees and demonstrate in the employment history possession of one or more of the following:*

- ✦ Earned Master's degree in field from an academic institution that is accredited by an institutional accrediting agency recognized by the United States Department of Education

**OR**

- ✦ Earned Master's degree with a concentration (a minimum of 18 graduate semester hours) in the teaching discipline\* from an academic institution that is accredited by an institutional accrediting agency recognized by the United States Department of Education, and, documented passing Score in the teaching discipline on the Education Certification Exam (ex: TCT, Praxis, GACE, etc.)
- ✦ Documented teaching experience in the secondary or postsecondary level

**Other/Alternative Qualification** – Applicants who do not meet the standard academic qualification may be considered under the following criteria:

**Minimum Qualifications:** *Must upload transcripts which show conferred educational degrees and document qualifications in the employment history:*

- Earned Bachelor's degree with a concentration (a minimum of 18 semester hours) in the teaching discipline\* from an academic institution that is accredited by an institutional accrediting agency recognized by the United States Department of Education, and, file for a certification exam waiver

**Preferred qualifications:** *Preference may be given to applicants who, in addition to meeting the minimum qualifications, provide transcripts of conferred degrees and demonstrate in the employment history possession of one or more of the following:*

- ✦ Earned Master's degree from an academic institution that is accredited by an institutional accrediting agency recognized by the United States Department of Education (*Bachelor's degree in field from an academic institution that is accredited by an institutional accrediting agency recognized by the United States Department of Education may be considered*) with demonstrated competence\* in teaching discipline.
- ✦ Documented teaching experience at the postsecondary level.

\*Candidate must upload the [CGTC Faculty Qualification Equivalency Form](#) and supporting documentation with their CGTC application demonstrate qualifications specific to the teaching discipline

**Projected Work Hours/Location:**

This position generally works normal day hours between 7:45 a.m. to 4:45 p.m. Monday through Thursday, and between 7:45 a.m. to 3:30 p.m., Friday and is limited to a maximum of 29 hours per week during the academic term. Actual class time(s) and day(s) have not been determined for Spring Term 2025 (begins January 2025). Class schedule may vary each academic term.

**Salary / Benefits:**

**This position is paid a \$26 gross hourly rate.** Adjunct positions are temporary, time-limited appointments encompassing a single academic term or period and do not imply or suggest a continuance of employment or a promise of future full-time employment. CGTC is a member of Teachers Retirement System of Georgia (TRS) and Employees Retirement System of Georgia (ERS). Adjunct positions are not eligible for TRS or ERS retirement benefits, state insurance, leave or holiday pay.

**Application Procedure:**

Applicants are required to complete the employment application in full and provide supporting documentation by the stated closing deadline for the position. GCTC does not accept mailed, faxed, or hand-delivered applications.

Applicants who complete the application procedure will be evaluated for meeting the position requirements based on the published job responsibilities, meeting the minimum and preferred qualifications based on the educational history, employment skills presented under job duties in the application system against the published job announcement. A completed application packet consists of the following:

1. A completed CGTC electronic application in the CGTC application portal.
2. As applicable, applicants for instructional positions are asked to provide a resume in addition to completing the CGTC application. Applicants for non-instructional positions may provide a resume if they wish. Submission of the resume does not replace the requirement to complete the CGTC electronic application.
3. Postsecondary transcripts that demonstrate the conferral of the degree, if applicable, and demonstrates the applicant meets the educational minimum requirements and, if applicable, the preferred educational requirements (*grade reports and diploma copies are not accepted in lieu of transcripts*)
4. Positions requiring a High School Diploma or GED as a minimum qualification do not have to submit a HSD/GED transcript documentation as part of the application process
5. Non-photo license(s) and/or certification(s) which fulfill the minimum, and if applicable the preferred qualifications stated in the job announcement

Incomplete application packets at the time of the position closing may not be considered. It is the responsibility of the applicant to obtain and upload the application documentation by the stated deadline.
