Job Summary:

Georgia Northwestern Technical College is seeking qualified applicants for the position of Registered Nursing Clinical Instructors for Med/Surg, OB, Pediatrics and Mental Health. GNTC Faculty may be asked to supervise students on any of our campus locations and may also teach dual enrolled students. May be required to travel to other campuses to meet operational requirements.

Duties/Responsibilities:

- Collaborate with faculty to meet the needs of the students
- Provide a variety of learning experiences consistent with the program mission, philosophy and nursing education outcomes
- Implement, operate, and participate in clinical activities to guarantee a high-quality, safe, and consistent clinical experience
- Demonstrates effective working relationships with individuals and groups

- Other duties assigned.

Required Qualifications:

Bachelor of Science in Nursing. Minimum of one to three years of licensed nursing practice within the last seven years. Clinical experience in one of the following areas: Med/Surg; pediatrics; OB; mental health. Hold an unencumbered Georgia license or eligible for licensure in Georgia and Tennessee. Be in good

standing from the initial date of employment as a registered professional nurse. Excellent communication and interpersonal skills.

Preferred Qualifications:

MSN degree. Previous teaching experience.

Physical Demands:

Work is typically performed in a classroom or office environment with intermittent sitting, standing, or walking in various settings. The employee occasionally lifts or moves objects to a light to medium weight. Full range of hand and finger motion may be utilized for data entry purposes. If the job involves driving, physical requirements include the ability to operate a vehicle and sit for extended periods.

Salary: ASN- \$33.66/hr; BSN & above- \$38.76/hr

Benefits:

If this is a part-time position, no benefits are available. If this is a full-time position, benefits include: 13 paid State holidays, annual and sick leave, paid parental leave, a State of Georgia benefits package that includes Health, Dental, Vision, Life, etc. A choice of two retirement systems: Teachers Retirement System of Georgia or the Employee's Retirement System of Georgia based upon position and 401K options.
